### **Hail damage dent and buckle check with dentCHECK during aircraft phase-out**



# About Condor

## Challenge

Condor recently renewed its complete long-haul fleet and therefore phased out the entire Boeing 767 fleet. During the phase out process of the last B767, an AOG-level hail damage dent mapping inspection was urgently required before returning it to the lessor. With time constraints in mind, the Condor team actively pursued innovative technologies to expedite the inspection process while maintaining the highest quality standards.
